Regulations for the use of electric car charging stations in the St. Bruno's hotel parking lot in Giżycko

§1

- These regulations ("Regulations") regulate the rules of using electric car charging stations in the parking lot of the St. Bruno Hotel in Giżycko, , 11-500 Giżycko, 1 St. Brunon street ("Parking").
- 2. The Regulations were established by the Management Board of Zamek Giżycko Ltd., which is the owner of St. Bruno Hotel ("Hotel"). The regulations may be changed at any time.
- 3. There are two (2) marked electric car charging stations in the Car Park, each including technical infrastructure and a separate parking space intended for the car to be charged, one (1) of which is intended for Tesla electric passenger cars and one (1) for electric cars of other makers ("Charging Stations").
- 4. The Regulations apply to all persons using the Charging Station. People and cars that violate the provisions of these Regulations, may be removed by the Hotel from the Charging Station.
- 5. Every driver that uses the Charging Station agrees to the provisions of the Regulations, undertakes to comply with them and bears responsible towards the Hotel for not complying with the Regulations.

§2

- 1. The use of the Charging Station is allowed 24 hours a day, on all days of the week.
- 2. The Charging Stations are intended only for charging electric passenger cars i.e. cars with electric drive and may not be used for parking cars or other vehicles.
- 3. Price list for electric car charging stations:
 - a. Guests using the services of St. Bruno Hotel **** free of charge upon presentation of the hotel card
 - b. Guests of Zamek Hotel ** and those not using the services of St. Bruno Hotel **** PLN 70.00
 - c. The Hotel may at any time prevent people from using the Charging Station who do not at the same time use other hotel services.

§3

1.

The basic rules for using the Charging Station include:

- Use of the Charging Station only while the car is being charged.
- 2. Self-connection of the Charging Station plug to the car by the person driving the car.
- 3. It is strictly forbidden to use the Charging Station by.
 - a. Cars transporting flammable, corrosive, explosive and other similar materials or substances that may pose a threat to people and property,
 - b. Cars serving as doorstep stores, if their purpose is to conduct business in the Parking lot,
 - c. Diesel only cars.
 - 4. It is forbidden to leave animals in the car at the Charging Station.
 - 5. Placing the car on the premises of the Charging Station, immobilizing it, turning off the engine and lights, closing the windows, the doors and the trunk.
 - 6. Self-securing the car against theft or burglary by the driver of the vehicle.
 - 7. Leaving the Charging Station plug in place after charging is complete.

- 1. Any interference with the technical infrastructure of the Charging Station is forbidden.
- 2. The reception at St. Bruno Hotel should be notified immediately about any irregularities in the functioning of the Charging Station, as well as in case of any doubts as to how to use the Charging Station.

§5

The manager is not responsible:

- 1. For the consequences of using the Charging Station in a manner inconsistent with its intended use or the Regulations
- 2. For any interruptions in the functioning of the Charging Station; each of the Charging Stations may be at any time, either temporarily or permanently, out of service.
- 3. For any damage caused by force majeure, theft (burglary, robbery etc.), destruction or damage to cars located on the premises of the Charging Station, as well as things left in them or constituting their accessories.
- 4. For the effects of third party action.

§6

- 1. In the event of a breach of the provisions of the Regulations by the user, the Hotel may apply measures necessary to restore the condition in accordance with the Regulations, which include: removing the car from the Charging Station or applying a mechanical car lock.
- 2. In the cases specified in sec. 1 the car user is required to cover the costs related to the removal of the car from the Charging Station and its protection and for storage until the car is picked up by the user by paying a fee in in the amount of PLN 500.
- 3. The user is responsible for any damage caused by the vehicle or damage caused in connection with the use of the Charging Station.
